1. Introduction to Online Reporting

The Gutmann App provides you with a fast and secure access to Gutmann's digital services. Our online reporting gives you a detailed overview of your investments with Gutmann

- Detailed overview of your investments
- Performance of your investments
- Overview of account and securities holdings and turnover
- Encrypted messages to your account manager
- Transmission and storage of important documents and client information

This guide is intended to assist you in setting up your access and using Gutmann Online. If you have any further questions, your relationship manager will be pleased to assist you at any time.

2. Registration Gutmann App

To use the Gutmann Online services, you must first register your mobile device. To do this, first download the app from the App Store or Google Play Store.





For the next steps, please have the QR code and the one-time password you received from us ready.

4. Device Management

The gear wheel symbol \bigotimes , which you will find as the last symbol in the menu bar on the left, takes you to the device management. On mobile devices or smaller screens, the menu bar must first be opened via the menu symbol in the upper right corner. In the device administration it is possible to register further mobile devices or to remove connected devices (e.g. if you use a new mobile device).

If only the Secure Mail is used within the framework of Gutmann Online, the cogwheel symbol is located in the upper menu bar.

In addition, all links to relevant information, such as the terms of use, the manual, etc., can be found under this menu item.


4.1. Adding another mobile device




## 5. Secure Mail

In addition to online reporting, Gutmann Online also offers a secure communication exchange between you and Gutmann employees. Secure Mail can be used both as a separate function and in combination with Online Reporting.

If you only use the Secure Mail, you can access your inbox immediately after logging in.






## 5.1. Notifications

When we write you a message, you will receive notice sent to your standard email address stating that there is a message in your Secure Mail inbox. You also have the option of receiving this information directly on your mobile device via a push notification.

You will find the settings for this in the "Settings" subfolder of the Secure Mail program.





## 5.2. Mail-Folder

When you open Secure Mail, you will see the inbox. A list of received mails is displayed. If you click on a message, it is displayed on the desktop in the window to the right of the list. On smaller screens or mobile devices, a new view opens.

## 5.3. Writing a message

Click on the button New Message or on 🗹 mobile devices to write a new message.

In the Recipient field you can enter the e-mail address of the Gutmann employee who is to receive the message. Your contact persons are already stored and can be selected in the drop-down menu.

## 6. Online Reporting

Gutmann Online Reporting offers detailed information on transactions and positions, access to a wide range of documents as well as a variety of analytical tools for your portfolio. Below, you will find a brief description of the types of information and functionalities available.

## 6.1. Home page and menu navigation design

On the home page of Online Reporting, you can see, at a glance, some key information and the contact details of your personal relationship manager.

The simple menu on the left-hand side of Online Reporting guides you through all the data and analyses available. The latter are filled with the data selected based on the global parameters chosen in the top right corner.

#### 6.1.1. Menu items available

On the left-hand side of the Online Reporting page, a menu is displayed that guides you through the pages available. The first item takes you to the home page, which provides concise information and your relationship manager's contact details. This is followed by the menu item "Asset analysis", which shows the current composition of your assets as



well as your asset allocation history. Under the menu item "Performance", you will moreover find various analytical options in the form of line charts.

The two next menu items "Positions" and "Movements" provide details on all account and securities account holdings as well as full details on past movements in your account and securities account.

The menu item "Documents" holds all documents made available to you under the Online Reporting service in the form of reports or online documentation. The menu item "Information on Online Reporting" comprises this User Manual as well as the terms and conditions for use and legal information.

Finally, the menu item "Message to client relationship manager" enables you to send a message to your personal relationship manager right from the Online Reporting service.

#### 6.1.2. Global parameters

These are displayed in the top right corner of Online Reporting and allow you to select your client numbers, to define a specific time period and to change the reporting currency. The de-fault setting is the year-to-date period. If you wish, your client relationship manager can change your preferred default reporting currency and the client number to be selected when you log in to the service.

#### 6.1.3. Customized home page

Depending on the level of detail you want to display on your home page, you may opt for one of two different home pages.

The standard home page provides you with a good overview of your current assets, year-to-date performance and the latest news.





8.1. Security

Security of your data is important to us. Therefore, strong customer authentication is used as part of 2-factor authentication when logging into Gutmann Online. The strong customer authentication is based on the use of two or more elements categorized as possession (something only the authorized person has), knowledge (something only the authorized person knows) or inherence (something the authorized person is), that are independent, in that the breach of one does not compromise the reliability of the others, and is designed in such a way as to protect the confidentiality of the authentication data.

8.2. Technical information

Due to the large data volumes that are sometimes available in Online Reporting, use of the Microsoft Internet Explorer may occasionally lead to lengthy loading times. For best results in using the features of the new Online Reporting system, we recommend you use the browsers Microsoft Edge, Google Chrome, Mozilla Firefox or Safari.
